OBJECTIVE of TRS

To measure the average time taken for each activity of the release process

To identify the weaknesses and suggest ways to remove them, if any.

SCOPE of TRS

Measures the mean average time taken in each process of Customs clearance from Filing of SB to Closure of EGM.

Is based on the declarations filed and processed electronically.

More than 99% of export declarations are filed electronically in Custom House.
