Sub: Establishment – Chennai Custom House – III DPC for the year 2016–17 for promotion to the Grade of Appraiser on regular basis – Willingness called for from Inspector (Preventive Officer) – reg.

It is proposed to fill up the vacancies for the year 2016-17 in the grade of Appraiser, on account of additional vacancies that have arisen due to promotion to the grade of Assistant Commissioner of Customs & Central Excise, voluntary retirement etc.

2. As per Department of Revenue (Customs Appraiser) Recruitment Rules 1988, Inspector (Examining Officer) / Inspector (Preventive Officer), who have put in three years of regular service, as on 01.04.2016, are eligible to be considered for promotion to the grade of Appraiser.

3. Such of those Inspectors (Preventive Officers), of Chennai, Vizag and Cochin Custom Houses who are willing to be considered for promotion to the grade of Appraiser may give their willingness in writing, in the following format, to the respective Joint Commissioner of Customs (P&V) on or before 10.03.2017:-

“I. -----, Inspector (Preventive Officer), am willing to be considered for promotion as Appraiser on regular basis. I clearly understand that definite quota has been prescribed for Inspector (Preventive Officer) for promotion as Appraiser. In the event of my promotion as Appraiser, I will not be allowed to revert to my parent cadre”.

4. Mere expression of willingness does not guarantee promotion to the grade of Appraiser.

5. If no willingness is received within the stipulated date, it will be construed that the officer is not willing to be considered for promotion to the grade of Appraiser.
