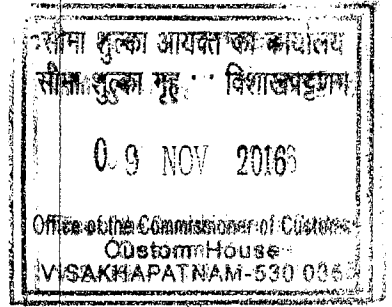

Sub: **Preparation of panel for appointment of Intelligence Officer in the Directorate General of Central Excise Intelligence, Bangalore Zonal Units and its Regional Units at Kochi, Belgaum & Mangalore on deputation basis -reg.**

Directorate General of Central Excise Intelligence, Bangalore Zonal Unit is in the process of drawing a panel of willing and suitable officers for filling up the vacancies in the grade of Intelligence Officer on deputation for the **Bangalore Zonal Unit and its Regional Units at Kochi, Belgaum & Mangalore.**

2. It is proposed to fill up these vacancies by appointing suitable officers from the grade of Inspectors of Central Excise, Service Tax & Customs, on deputation basis.
3. Selected officers, while working in the Directorate in the grade of Intelligence Officer on deputation basis, will be entitled for Special Allowance as admissible. Normally, the deputation is for a period of five years, subject to the willingness of the officer, his/her performance, concurrence of his parent Commissionerate and approval of the competent authority.
4. Details of vacancies is enclosed in Annexure to this letter.
5. It is requested that the circular may please be brought to the notice of all the formations under your jurisdiction and the applications of willing officers be forwarded to this office. While forwarding the names of the willing officers, the following information may also be sent for evaluation by this Directorate

6. (a) Complete bio-data and willingness of the officer alongwith history of postings , place of postir g willingness to work.
(b) ACR, APAR gradings for the last 5 years (duly verified and attested by the Addl./Joint Commissioner (P&V)).
(c) Vigilance Clearance
(d) 'No objection' from the Cadre Controlling Authority to relieve the officer in the event of his selection.
7. The above information/details may please be arranged to be furnished to this Directorate General by **10/12/2016**.
