CIRCULAR

Sub:- Establishment - Preparation of panel of Air Customs officers
for posting to Anna International Airport, Chennai – Reg.



It is proposed to draw a panel of Inspectors (Preventive Officers) of Custom House. Visakhapatnam for posting at Anna International Airport, Chennai against the 75% quota.

The terms and conditions for selection and posting to Anna International Airport. Chennai are as under:

1. The Officers posted at the Airport will be eligible to draw pay and allowances at the same rates admissible to them.
2. They shall be considered as on deputation at the Airport, but no deputation allowance is admissible to them.
3. Normally, the period of deputation at the airport is two years. However, an officer at the Airport can be repatriated before completion of 2 years without assigning any reason.
4. The officer posted at the Airport will have to make their own arrangements for residential accommodation.
5. The officer will also be entitled to draw uniform allowance and diet allowance as admissible under the rules.
6. In the event of their promotion to the higher cadre, the officers are liable to be repatriated to their parent Commissionerate or posted anywhere as may be ordered by the competent authority on this subject.
7. The following officers are not eligible for consideration for posting at Anna International Airport, Chennai.
 - a. Officers transferred out of Airport / Sensitive places on administrative grounds.
 - b. Officers due for retirement within the next 2 years.
 - c. Officers having less than 2 years cooling off period on their return from Airport / DGRI / DGAE / NCB / ED (FEMA) / EIB in terms of Ministry's Instructions issued in F. No. A-35017/28/92-Ad.III-B, dated. 30.06.1994. (The condition of "Cooling off period" will not be applicable for officers posted in AIU for the purpose of their selection for the Airport).
 - d. Officers with Vigilance / Non-vigilance cases.
 - e. Officers against whom penalty is operative.
 - f. Officers with less than 3 years service.
8. The Screening Committee will frame its own criteria in selecting the suitable candidates and the selected candidates will be sent to deputation subject to the administrative requirement.
9. The Officers who are willing to be posted as ACOs at Anna International Airport. Chennai under the terms and conditions specified above may submit their willingness to Establishment section latest by **15.06.2018**.
10. **Withdrawal of willingness once given will not be entertained under any circumstances. This issues with the approval of the Commissioner of Customs.**
