
Sub:- Establishment - Preparation of panel of Air Customs Superintendents
for posting at Anna International Airport, Chennai - Reg.

It is proposed to draw a panel of Superintendents of Customs (Prev), Custom House, Visakhapatnam for posting at Anna International Airport, Chennai against the 75% quota.

The terms and conditions for selection and posting to Anna International Airport, Chennai are as under:

1. The Superintendents posted at the Airport will be eligible to draw pay and allowances at the same rates admissible to them.
2. They shall be considered as on deputation at the Airport, but no deputation allowance is admissible to them.
3. Normally, the period of deputation at the airport is two years. However, a Superintendent at the Airport can be repatriated before completion of 2 years without assigning any reason.
4. The Superintendents posted at the Airport will have to make their own arrangements for residential accommodation.
5. The Superintendent will also be entitled to draw uniform allowance as admissible under the rules.
6. In the event of their promotion to the higher cadre, the Superintendents are liable to be repatriated to their parent Commissionerate or posted anywhere as may be ordered by the competent authority on this subject.
7. The following Superintendents are not eligible for consideration for posting at Anna International Airport, Chennai.
 - a. Superintendents transferred out of Airport / Sensitive places on administrative grounds.
 - b. Superintendents due for retirement within the next 2 years.
 - c. Superintendents having less than 2 years cooling off period on their return from Airport / DGRI / DGAE / NCB / ED (FEMA) / EIB in terms of Ministry's Instructions issued in F. No. A-35017/28/92-Ad.III-B, dated. 30.06.1994. (The condition of "Cooling off period" will not be applicable for officers posted in AIU for the purpose of their selection for the Airport).
 - d. Superintendents with Vigilance / Non-vigilance cases.
 - e. Superintendents against whom penalty is operative.
 - f. Superintendents with less than 3 years of service.
8. The Screening Committee will frame its own criteria in selecting the suitable candidates and the selected candidates will be sent on deputation subject to the administrative requirement.
9. The Officers who are willing to be posted as ACSs at Anna International Airport, Chennai under the terms and conditions specified above may submit their willingness to Establishment section latest by **17.11.2017**.
10. **Withdrawal of willingness once given will not be entertained under any circumstances. This issues with the approval of the Commissioner.**
