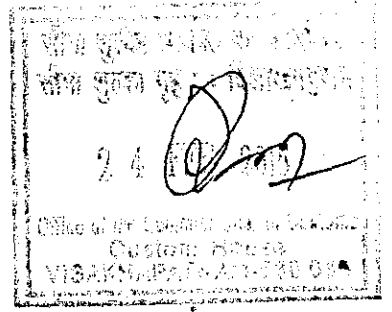

Sub: Appointment of Inspectors in CBI on deputation – Reg.

Central Bureau of Investigation, Hyderabad Branch intends to induct suitable Officers to work as Police Inspectors in the Grade Pay of Rs.4,600/- in PB-2 (Rs.9300-34800) on deputation basis from various Police forces, Central Excise, Customs, Income Tax etc.

Central Bureau of Investigation offers very challenging and professionally satisfying environment to Police Inspectors who would get an opportunity to investigate important cases of anti-corruption and other cases referred by the higher Courts and Governments.

The criteria for inducting Officers on deputation in the rank of Inspector has been mentioned in the CBI Recruitment Rules, 2013 (Group 'B' and Group 'C' Executive Posts), a copy of which is already available on CBI website "[www.cbi.gov.in](http://www.cbi.gov.in)".

Eligibility criteria as mentioned in the said Recruitment Rules for induction as Inspector on deputation in CBI are given below for ready reference:

- The Officer must be a graduate from a recognized University.
- Officer of Central or State Police Forces holding analogous posts on regular basis in parent cadre/department and with five years of regular

service in the grade of Sub-Inspector of Police in the Pay Band-2, Rs.9300-34800/- plus grade pay of Rs.4,200/-.

- c) Inspectors of Railway Protection Force or Inspector of Central Excise and Customs or Preventive Officers Grade-I or Examiner in Customs Office or Income Tax Inspectors or persons working in the analogous post on regular basis under the State Government and possessing at least five years executive experience in vigilance or investigation or intelligence work.

The Recruitment Rules provide for an initial deputation tenure of 5 years which can however be extended up to 10 years with the approval of the competent authority.


In addition to the Pay in PB-2 with Grade Pay of Rs.4,600/-. Officers joining on deputation as Inspectors are entitled for a special incentive of 25% of Basic Pay plus Dearness Allowance, Cash Compensation equivalent to one month's basic pay and Dearness Allowance in lieu of working on holidays, ad-hoc bonus declared by Central Government on completion of six month service in a financial year and Any Place in India LTC once in four years etc.

It is, therefore, requested to circulate our requirement among the eligible Officers of your Department/Organisation and send us the particulars of eligible and willing officers in the enclosed proforma along with following documents:

- a) Attested copies of ACRs for the last five years.
- b) NOC with reference to willingness of competent authority to spare his services on deputation as Police Inspector in CBI.
- c) Vigilance Clearance Certificate
- d) Record of departmental or criminal cases, if any, against the officers in the past 10 years.

The matter may kindly be given priority.
