Sub: Establishment-Custom House-Visakhapatnam-Promotion to the grade of Superintendent of Customs (Preventive)-Reg.

In pursuance to the Hon'ble Supreme Court judgment on 27.11.2012 in the case of UOI vs NR Parmar and the judgment passed by the Hon'ble CAT, Hyderabad in OA No 1478/2014, a revised seniority list of Inspectors (POs) has been issued on 21.03.2016 revising the Seniority List dated 21.02.2013. Basing on the same revised seniority list, a DPC for promotion to the grade of Superintendent of Customs (Prev) was held on 23.06.2016, to review the proceedings of the DPCs held on 24.09.2014 and 30.03.2015.

2. Consequent to the review by the DPC as above, the following officers in the grade of Inspectors (POs) are being promoted on regular basis in the grade of Superintendent of Customs (Prev), Group 'B' (Gazetted), in the Pay Band -2 of Rs 9300-34800 with Grade Pay of Rs 4800/- plus usual allowances as admissible, with effect from the date as mentioned against their names :

- 3 The Officers are informed that the promotion now made does not confer on them any right for eligibility or seniority and is without prejudice to the valid claims of other Officers entitled for promotion to the grade of Superintendent (Preventive) arising out of any future Revision of Seniority on any account whatsoever.
- 4 The officers at SI No 13 to 17 of the list pre-page are deemed to be promoted notionally with effect from the dates mentioned against their name.
- 5 The officers at SI No 21 to 28 of the list pre-page are promoted notionally with effect from the dates mentioned against their names and actually from the date of assumption of charge as Superintendent of Customs (Prev).
- 6 The Officers at SI No 21 to 28 shall join the new post on or before **08.07.2016**.
- 7 Non acceptance of the promotion may lead to disciplinary proceedings under CCS Rules or non-consideration of the Officer for promotion to the grade of Superintendent of Customs (Preventive) for one year. If the officer submits a representation seeking extension of time and if he/she does not get a reply before the last date fixed for joining, it should be treated that, the representation has been rejected. If the officer does not join within the prescribed period or extension thereof, it will be construed that the officer has refused to accept the promotion. It is also informed that no specific order cancelling the promotion will be issued.
- 8 The officials are informed that their seniority is liable to be changed due to Judicial and Administrative Orders.
- 9 The appointment is purely on officiating basis and the officials are liable for reversion at any time, if found necessary.
- 10 The promotion made vide this order is provisional and is subject to any review that may happen in any contingency like reduction in vacancies, fixation of seniority, panel year to which the chain vacancies relate, etc.
- 11 The Officers are eligible for fixation of pay under FR 22-1(a)(i) either straightway or from the date of accrual of next increment in the scale of the feeder cadre. They are hereby directed to exercise their option within one month from the date of this order. **The pay in the promotional post shall be drawn only from the actual date of assumption of charge and no arrears of pay and allowances are admissible for the period of notional promotion.**
- 12 If any Officer has been given the benefit of fixation of pay under the ACP Scheme, 1997/MACP Scheme, 2008, he/she shall not be eligible for any fixation now.
