Shri M. Dasan Babu, Executive Assistant is promoted to the grade of **Inspector (Preventive Officer)** in Level 7 of the 7th CPC Pay Matrix plus usual allowances as admissible with effect from 01.01.2019 as per the recommendations of the DPC held on 12.10.2018.

2. He is informed that the promotion now made does not confer on him any right and is without prejudice to the valid claims of other officers entitled for promotion to the grade of Inspector (Preventive Officer).

3. The Official shall join the new post **on or after 01.01.2019** and not later than **10.01.2019**.

4. Non acceptance of the promotion may lead to disciplinary proceedings under CCS Rules or non -consideration of the officer for promotion to the grade of Inspector (Preventive Officer) for one year. If the officer submits a representation seeking extension of time and if he/she does not get a reply before the last date fixed for joining, it should be treated that the representation has been rejected. If the officer does not join within the prescribed period or extension thereof, it will be construed that the officer has refused to accept the promotion. It is also informed that no specific order cancelling the promotion will be issued.

5. The Officer is eligible for fixation of pay under FR 22 either straightway or from the date of accrual of next increment in the scale of the feeder cadre. They are hereby directed to exercise their option within one month from the date of this order.

6. If he has been given the benefit of fixation of pay under the ACP scheme, 1997/MACP scheme, 2008, he shall not be eligible for any fixation now.
