Sub: Appointment of M/s GSEC Limited, as Operation and Marketing contractor for M/s APTPC Limited for the existing Air Cargo Complex at Visakhapatnam, Airport - Reg.

The trade, industry, Custom House Agents and all other concerned are hereby informed that M/s Andhra Pradesh Trade Promotion Corporation Limited (hereinafter referred as M/s APTPC Ltd.) who are notified as Customs Cargo Services Providers in terms of Handling of Cargo in Customs Areas Regulations, 2009, as amended (custodians) for the existing Air Cargo Complex, at Visakhapatnam Airport have entered into an agreement to grant the contract for Operation & Marketing to M/s Gujarat State Export Corporation Limited, Ahmedabad (hereinafter referred as M/s GSEC Limited), to handle international cargo at the existing Air Cargo Complex at Visakhapatnam.

2. Consequently, M/s APTPC Limited & M/s GSEC Limited, have applied to the Commissioner of Customs, Visakhapatnam seeking his approval for appointing M/s GSEC Limited as O&M Contractor for M/s APTPC Limited for the operation and marketing of the existing Air Cargo Complex at Visakhapatnam. The North-West corner room on the 1<sup>st</sup> floor of the Technical Building which is adjacent to the Airport Terminal building will be continued to be used for storage of precious/valuable cargo, while the godown at DCCB building, NH-5 road, Marripalem, Visakhapatnam, will be used for general cargoes and certain other categories of cargoes.

3. The Commissioner of Customs, Visakhapatnam, having considered their request, has given approval to M/s APTPC Limited for appointment of M/s GSEC Limited as their operation and marketing operator for the existing Air Cargo Complex at Visakhapatnam Airport as per the terms


and conditions mutually agreed upon by them, in their agreement. M/s APTPC Limited, however, shall, for all purposes, continue to remain as the Customs Cargo Services Providers (custodian) under the Customs Act, 1962, and shall be responsible for fulfilling its obligations as Customs Cargo Service Provider under the provisions of Section 45 of CA'62 and the Rules, Regulations, Notifications and Orders made there under. The Customs Cargo Service Provider (custodian) shall remain vicariously liable for all acts of omissions and commissions on behalf of the O&M operator appointed by them.

4. For clearance of import/export consignments from the Air cargo complex, the procedures laid down in the public notices No.37/94-Cus., dated 16.11.94; 38/2003, dated 19.02.2003 and relevant instructions issued in this regard from time to time may be followed.

5. You are also liable for necessary security checks/inspections from security point of view conducted by the Bureau of Civil Aviation.

6. Difficulties, if any, noticed in implementing the aforesaid may be brought to the notice of the undersigned.

7. This issues with the approval of Commissioner of Customs, Custom House, Visakhapatnam.
