**PUBLIC NOTICE NO. 15/2017**

**Sub: Oral Test for 'G' Card of Custom Broker employees, holding 'H' Card under Regulation 17 of Custom Broker Licensing Regulations, 2013 scheduled to be held in the month of May, 2017 – Reg.**

Attention of the Custom Brokers is invited to Regulation 17 (3) of the Custom Broker Licensing Regulation, 2013. In terms of the provisions contained therein, fresh applications are invited in prescribed proforma for the oral test, which is proposed to be conducted in the month of May, 2017, in respect of those candidates who have qualified in the written test conducted by this Custom House but did not appear or pass the oral test. It is also to inform that those Candidates who have qualified in written examination held on 12.04.2017 need not apply separately for proposed Oral Test.

2. The Custom Broker are hereby informed that their employees who are holding Provisional Custom Pass in Form 'H' are required to qualify in the examination under Regulation 17 (3) of CBLR, 2013 in maximum four attempts from the date of issue of 'H' Card.

3. Willing Custom Broker is therefore directed to submit the application(s) in respect of their present eligible employees who are willing to appear in the said examination.

**Note:** Candidates are requested to verify their eligibility criterion before submission of their application.

4. **Format of Application:**

The applications duly sponsored by the Custom Broker should be submitted in the format as prescribed at Annexure 'A'.

5. **Documents to be attached with the application:**


- i. An attested photo copy of 10+2 passed or equivalent exam
- ii. Photo Copy of valid customs Identity 'H' Card
- iii. Photo Copy of valid Customs Broker Licence
- v. If there is any change in name, Gazette Notification/Marriage Certificate in support of such change
- vi. Proof of residence
- vii. Copy of Pass Certificate for written examination issued by the Custom House

6. The roll numbers of eligible candidates, date, time and venue for oral test will be displayed on the Notice Board of the Custom House and also on the official website of Custom House, Visakhapatnam at [www.vizagcustoms.gov.in](http://www.vizagcustoms.gov.in) after scrutiny of the applications.

7. All the Custom Brokers are directed to ensure that the information furnished by them and sponsored candidates in the application are true. Any mis-declaration will be viewed seriously and suitable action will be taken in accordance with the provisions of CBLR, 2013.

8. **Last date for receipt of Applications:**

Applications can be submitted by hand/post in the Custom Broker Section on or before 17.00 Hrs. of 17.05.2017. Applications not in the prescribed format or received after expiry of the last date, will not be entertained under any circumstances.
