Kind attention of all importers/exporters, Customs Bonded Warehouses Licensees, Customs Brokers and the members of Trade is invited to this office Public Notice No. 26/2018 dated 27.06.2018 regarding implementation of electronic sealing (RFID seals) for deposit in and removal of goods from Customs bonded warehouse in terms of Board's Circular No. 19/2018 dated 18.06.2018.

2 In this connection, requests have been received by Board from the trade that for warehouse to warehouse transfer, the owner of the goods should be allowed to procure a RFID seal from the destination warehouse instead of originating warehouse.

3 The same was examined by Board. As per para 4.5 (d) of Circular 19/2018-Customs, any importer permitted to remove goods for deposit in a warehouse shall obtain a RFID seal from the warehouse, where the goods are to be deposited. Thus, the RFID seals are to be procured from the destination warehouse. Allowing the owner of the goods to procure a RFID seal from the destination warehouse also obviate the need for development of any universal application by all vendors or the need for procuring multiple readers by warehouse owners. Therefore, even in case of warehouse to warehouse transfer, it is clarified that the RFID seals shall be procured from the destination warehouse.

4 Accordingly, Board has updated para 4.5(d) of Circulars 19/2018-Customs dated 18.06.2018 vide Circular 39/2018 dated 23.10.2018 as mentioned below:

*“Any importer permitted to remove goods for deposit in a warehouse shall obtain an RFID seal from the Warehouse where the goods are to be deposited.
Provided that for warehouse to warehouse transfer the owner of the goods shall procure a RFID seal from the destination warehouse.”*

5. Board Circular 19/2018- Customs DT 18.06.2018 as updated above will be effective from 01.11.2018.
