**PUBLIC NOTICE NO: 47/2017**

Attention of all Trading Public , all importers , exporters and Custom House Brokers is invited to the Public Notice No. 42/2017 dated 10.10.2017 & Public Notice No. 01/2011 dated 10.01.2011 wherein the Commissioner of Customs approved M/s Andhra Pradesh Trade Promotion Corporation Limited (APTPC Ltd) to operate as Custodian of the new premises at Ground Floor of Old Terminal Building ,International Air Cargo Complex, Visakhapatnam Airport for all import and export of Air Consignments and also given approval to M/s APTPC Limited for appointment of M/s Gujarat State Export Corporation Ltd, Ahmedabad (hereinafter referred as M/s GSEC Limited) as their operation and marketing operator.

M/s GSEC Limited is continued to be the O&M Contractor for M/s APTPC Ltd for the operation and marketing of the new premises at Air Cargo Complex , Visakhapatnam as per the terms and conditions mutually agreed upon by them, in their agreement . M/s APTPC Ltd , however, shall, for all purposes, continue to remain as the Customs Cargo Services Providers (Custodian) under the Customs Act, 1962, and shall be responsible for fulfilling its obligations as Customs Cargo Service Provider under the provisions of Section 45 of Customs Act, 1962 and the Rules, Regulations, Notifications and Orders made thereunder. M/s APTPC Ltd, being the Custodian, shall remain vicariously liable for all acts of omissions and commissions on behalf of the O&M operator appointed by them.

3. For clearance of import/export consignments from the Air Cargo Complex , the procedures laid down in the Public Notice 42/2017 dated 10.10.17 and relevant instructions issued in this regard from time to time may be followed.

4. You are also liable for necessary security checks/inspections from security point of view conducted by the Bureau of Civil Aviation. ;

5. This issues with the approval of Commissioner of Customs, Custom House, Visakhapatnam.
