ANNEXURE-I
(Terms and conditions)

1. The vessels can be inspected for the works to be carried out at Sea Port near Jubilee Gate, Visakhapatnam Port Trust on any working days with prior intimation.
2. You may also inspect fitted systems and equipment of the vessel and their controls for any defects for consideration for estimation.
3. The firm should be an authorized dealer of CAT-III A fibre Speed boats and Mercury Marine (OBM), having workshop facility for overhauling of OBM and should be able to arrange all requisite spares.
4. All spares, consumables, paints, oil & lubricants, materials etc, required to carry out repairs shall be supplied by the firms including crane services and transportation, if required.
5. After completion of works, sea trials at full powers to be conducted for satisfactory performance of all machineries, equipment and systems fitted on the vessel.
6. The work carried out should be guaranteed for a period of 12 months from the date of successful trials of the vessel.
7. The firm is required to complete the repair works and sea trials within 45 days from the date of work order. In case the repairs are not completed within the time frame, liquidated damage of Rs. 2000/- per week, till completion of works and sea trials shall be deducted from the payment.
8. In case of any dispute of any kind and in any respect whatsoever, the decision of Additional Commissioner of Customs, Visakhapatnam shall be final and binding.
9. The service provider will comply with the labour laws in force and all liabilities in this connection will be theirs.
10. The quotation received after the specified date and time of receipt shall not be considered.
