Whereas EQ-9 Berth of M/s Vizag Seaport Private Limited (VSPL), Visakhapatnam has been notified vide notification No.03/2004(CUSTOMS) (NT) (VSP) dated 14.09.2004 under Section 8 of the Customs Act, 1962 (52 of 1962) to be a proper place for loading and unloading of goods and specifying the limits of the area and boundaries of M/s VSPL, issued from F. No. S10/13/2004-Prev.

Now, in exercise of the powers conferred under Section 8(b) of the Customs Act, 1962(52 of 1962), I, B. Hareram, Commissioner of Customs, Visakhapatnam, on the request of M/s VSPL vide letter Ref. No. 01:017:001/1290/2016-17 dated 02.03.2017 and Visakhapatnam Port Trust(VPT), Visakhapatnam vide their letter No. ITRA/GEN/FEQ10 dated 17.02.2017, **de-notify** an area to an extent of 765 Sq. Mtrs (60Mtrs length X12.75 Mtrs. width) in the Northern Arm of Inner Harbour of Visakhapatnam Port of the declared Customs Area of EQ-9 Berth of M/s VSPL, as per enclosed drawing to enable VPT to hand over the same area to M/s AVR INFRA Private Limited for developing EQ-10 Berth. The notification No. 03/2004 (CUSTOMS) (NT) (VSP) dated 14.09.2004 stands modified to this extent.

The measurements and boundaries of the de-notified portion of the EQ-9 Berth of M/s VSPL are as under:
