ORDER

Sub: Appointment of M/s. CONTAINER CORPORATION OF INDIA LIMITED  
MULTI MODAL LOGISTICS PARK as Custodian of Import and Export  
goods under Section 45(1) of the Customs Act, 1962 – reg.

In Pursuance of the powers conferred under Section 45(1) of the Customs Act, 1962 (52 of 1962), I, C. Rajendiran, Principal Commissioner of Customs, Visakhapatnam, hereby appoint M/s. Container Corporation of India Limited Multi Modal Logistics Park as custodian of all imported goods received in containers through Visakhapatnam and other ports / Customs stations and transported to the Container Freight Station located at Viman Nagar, opposite to airport, adjacent to NH-16, Visakhapatnam District, Visakhapatnam until these are cleared for home consumption or are warehoused or are transhipped in accordance with the provisions of Chapter VIII of the Customs Act, 1962. Similarly, they will be the custodian of export cargo brought into the CFS at Viman Nagar, opposite to airport, adjacent to NH-16, Visakhapatnam District, Visakhapatnam, for stuffing, accountal, Customs examination, transportation and safe delivery of Customs Sealed Containers for onward transshipment to the port of despatch.

2. M/s. Container Corporation of India Limited Multi Modal Logistics Park as Custodian of goods meant for export and import would be required to comply with the provisions of Section 45 (2) of the Customs Act, 1962 and the Handling of Cargo in Customs Areas Regulations, 2009 and subsequent amendments as well as rules and regulations and instructions issued from time to time on the subject matter.

3. The duration of the appointment shall initially remain valid for a period of 2 (two) years. The Principal Commissioner shall have the right to terminate the appointment at any time after assigning specific reasons and giving an opportunity to the Custodian to explain the case. The appointment shall be reviewed after 2 years. This CFS should not be used for other than the declared purpose.
