NOTIFICATION No.01/2015 (CUSTOMS) (NT) (VSP)

Sub: Declaration of Container Freight Station of M/s. CONTAINER CORPORATION OF INDIA LIMITED MULTI MODAL LOGISTICS PARK situated at Viman Nagar, opposite to airport, adjacent to NH-16, Visakhapatnam District, Visakhapatnam – 530009 as "Customs Area" for handling of Import and Export Cargo – regarding.

In exercise of the powers conferred under sub Section (a) of Section 8 of the Customs Act, 1962 (52 of 1962), I, C.Rajendiran, Principal Commissioner of Customs, Custom House, Visakhapatnam, hereby specify the area of M/s. Container Corporation of India Limited Multi Modal Logistics Park situated at Viman Nagar, opposite to airport, adjacent to NH-16, Visakhapatnam District, Visakhapatnam, as "Customs Area" for storage of containers and goods contained therein, imported through Visakhapatnam Port and for stuffing of export cargo and de-stuffing of import cargo exported/imported through Visakhapatnam Port.

Provided that the said premises shall remain in complete control of the Container Freight Station of M/s. Container Corporation of India Limited Multi Modal Logistics Park and that sealing of containers and stuffing / de-stuffing of export / import cargo is done under Customs Supervision.

In exercise of powers conferred under sub Section (b) of Section 8 of the Customs Act, 1962, I hereby specify the limits of the Customs area to an extent of 10.12 acres of M/s. Container Corporation of India Limited Multi Modal Logistics Park located at Viman Nagar, opposite to airport, adjacent to NH-16, Visakhapatnam District, Visakhapatnam with boundaries as under:

Northern side: INS Dega staff residential quarters.

Western side: Railway Line.

Eastern side: NH -16.

Southern side: Proposed MMLP Yard Phase-II.
