TRADE FACILITATION CIRCULAR NO. 3 /2011

Sub:- Valuation of Second Hand Machinery, Goods, etc. – Empanelment of Chartered Engineers – Reg.

A reference is invited to Public Notice No. 34/2008, dated 4.12.2008 issued by this Custom House on the above subject regarding empanelment of six Chartered Engineers. However, due to non-availability of the empanelled Chartered Engineers, a need was felt to enlarge the list by inducting new Chartered Engineers.

2. Accordingly, a Public Notice No. 30/2010, dated 22.11.2010 was issued calling for applications from eligible Chartered Engineers and a list of eight Chartered Engineers recommended by The Institution of Engineers (India), Koikata has been drawn up for empanelment.

3. The above list of empanelled Chartered Engineers is in addition to the list of six Chartered Engineers notified vide Public Notice No. 39/2008, dated 4.12.2008 and the list of Inspection / Certification agencies given in Appendix 5 of the Hand Book of Procedures (Vol.I) 2010-11.

4. The Chartered Engineers empanelled by Visakhapatnam Custom House and the Chartered Engineers / Agencies listed in Appendix 5 of the Hand Book of Procedures Volume-I, who are conducting valuation of second hand machinery/goods etc., imported through Visakhapatnam Custom House, have to submit yearly self appraisal report in the format prescribed in Annexure-I of this Trade Facilitation Circular and have to submit the same to the Commissioner of Customs before 30th April of every financial year to assess their performance and to decide whether they are fit to continue in the panel.

5. The self-appraisal report is to be scrutinized by SIIB and a report is to be submitted to the Commissioner of Customs for further action. If any of the empanelled Chartered Engineers are found to be involved in any offence relating to Customs classification, valuation, etc., their empanelment would be withdrawn and appropriate action would be initiated under the provisions of the Customs Act, 1962.
